DESCRIPTION

Records, 1963 - , of the Society for Photographic Education. Includes correspondence, minutes of board and executive committee meetings, treasurer's reports, budgets, questionnaires, membership files and directories, conference materials, and national and regional publications, including the journal, *Exposure*. The bulk of the material documents the period 1975-91. The collection is still active. 32 linear feet.

PROVENANCE

In 1985 the Board of the Society for Photographic Education named CCP as the sole and exclusive repository for its archives. This collection began as a gift from the Society in 1986.

RESTRICTIONS

Permission of SPE is required to read personal correspondence less than twenty-five years old.
